Chair Wynne Palermo called the meeting to order at 3:00 p.m.

Item 1 – Approval of the United States Olympic Museum and Hall of Fame Bond documents:

A motion was made by Commissioner Valerie Hunter, seconded by Commissioner Brian Olson to approve:

RESOLUTION NO: 02-17 AUTHORIZING THE ISSUANCE AND SALE OF COLORADO SPRINGS URBAN RENEWAL AUTHORITY TAX INCREMENT REVENUE BONDS (UNITED STATES OLYMPIC MUSEUM AND HALL OF FAME PROJECT) IN THE AGGREGATE PRINCIPAL AMOUNT OF \$39,000,000 TO FINANCE THE UNITED STATES OLYMPIC MUSEUM AND HALL OF FAME AND CERTAIN RELATED INFRASTRUCTURE; AUTHORIZING THE EXECUTION AND DELIVERY BY THE AUTHORITY OF AN INDENTURE OF TRUST, TWO REIMBURSEMENT AGREEMENTS, CLOSING DOCUMENTS AND SUCH BONDS IN CONNECTION THEREWITH; MAKING DETERMINATIONS AS TO OTHER MATTERS RELATED TO SUCH FINANCING; AND REPEALING ANY ACTION HERETOFORE TAKEN IN CONFLICT HEREWITH.

The motion passed 9 - 0.

Discussion followed:

Kurt Kaufman discussed the changes to the Indenture. David Neville discussed the reimbursement agreements. All the participants expressed appreciation for the group effort on this historic project. The closing will be Wednesday, April 12, 2017.

Wynne Palermo stated that the proposal to provide independent engineer or architect certification for construction related costs for the United States Olympic Museum and Hall of Fame Project from AndersonMasonDale Architects had been reviewed by the insurance carrier.

A motion was made by Commissioner Brian Olson, seconded by Commissioner Valerie Hunter to approve the AMD Independent Certification Engagement Letter. The motion passed 9-0.

There being no further business the meeting adjourned at 3:45 p.m.
