Chair Wynne Palermo called the meeting to order at 1:08 p.m.

Item 1 – South Nevada Avenue Urban Renewal Area Bonds:

Ray O’Sullivan, Ivywild Development gave a brief recap why it is the best action for them to use the Colorado Springs Urban Renewal Authority as the financing entity for the sale of bonds for the South Nevada Avenue Urban Renewal Area.

Commissioner Valerie Hunter entered the meeting.

Ray O’Sullivan distributed a copy of the Ivywild Creek District Master Plan map and gave an update on some of the anticipated construction projects. A new restaurant will be built where the old Craddock Building is located. Parking is evolving with 160 parking spaces built into the plan with the reserved right to build structure parking with residential above in the future. The park will feature farmer’s markets, concerts and other venues.

Commissioner Gary Feffer entered the meeting.

Sam Sharp, D.A. Davidson discussed their role in providing investment banking services to the CSURA regarding the South Nevada Avenue Urban Renewal Area Bonds. Tom Weihe, Kutak Rock, LLP also participated in the discussion with the CSURA Board. Please refer to the audio of the June 15th Special Meeting on the website for the complete discussion.

A motion was made by Commissioner Brian Olson, seconded by Commissioner Valerie Hunter to approve moving forward with the engagement of Kutak Rock, LLP as bond counsel to proceed with drafting of bond documents for the South Nevada Ivywild project based on the term sheet presented by D.A. Davidson, with D.A. Davidson as underwriter on the terms of their engagement letter as presented, subject to review by a financial advisor to be engaged by CSURA and agreement on a final engagement letter with Kutak Rock, LLP. The motion passed 9 - 0.

There being no further business the meeting adjourned at 2:15 p.m.
